The Board of Directors of the St. Ansgar Community School District met in regular session in the High School Media Center at 5:34 P.M.

Present: Directors Steve Groth, Will Morrow, Lindsey Falk, Kyle Tabbert, and Lowana Hannam. Superintendent Mike Crozier. Secretary Emily Johnson-Woods. Principal Lynn Baldus. 2 guests were present.

Absent: Directors Tara Bork and Donna Brumm.

The meeting was called to order by President Groth. Morrow moved, duly 2nd by Tabbert, to approve the agenda as presented. Ayes-Morrow, Falk, Tabbert, Hannam, and Groth. Nays-None.

There were no communications.

Administration Reports: Presented in packet. Principal Baldus told the board that Mitchell County Public Health is doing flu shots tonight from 5 to 7 if anyone present is interested.

Superintendent Crozier reported the enrollment number and the District is up 9.04 students at this time.

Superintendent Crozier presented on the District's Financial Status and the solvency ratio which is currently 9.67%, the District would like to see that number be around 15%. The District is also working on the Unspent Authorized Budget and getting that number up. The District is on the right track.

Superintendent Crozier updated the board on the new guidance from the Iowa Department of Education to not release the positive test results to public unless there are 6 or more cases. The School will follow those guidelines.

Director Falk and Director Morrow commented on the financials and that they are looking good.

Director Tabbert inquired about reaching out to district learners to see if everything is going well.

Director Falk inquired about the Elementary's new plan and how that is working out for them and if it has relieved some of their stress. Superintendent Crozier reported that at this time, it seems to be going well.

Falk moved, duly 2nd by Tabbert, to approve the Consent Action Items which included the following:

Lindsey would like to see a representative from the school be on the board to discuss the purchase and development to see if the costs could be shared for roads and anything else the land may need.

Falk moved, duly 2nd by Morrow, to set a public hearing for the participation in the Instructional Support Levy on November 9, 2020 at 5:35 P.M in the MS/HS Media Center. Ayes-Groth, Morrow, Falk, Tabbert, and Hannam. Nays-None.
